ASSOCIATE MEMBERSHIP APPLICATION

The North End Business Association consists of commercial properties, and businesses renting in commercial properties, within the geographic boundaries of an HRM approved business improvement district (BID). Member businesses pay a tax levy that sustains the BID association, and in exchange, member businesses receive services from the association according to the BID mission:

- *To create policies, events, awareness and momentum to build upon a successful, resilient business community;*
- *To be an influential advocate for the best conditions for sustainable business growth; and*
- *To support the development and retention of a diverse, inclusive and vibrant North End.*

In effort to promote the North End as “the place to do business,” NEBA is offering an Associate Membership to all businesses, including home-based businesses, within the NEBA Associate Membership Area (see map.) Applicants must actively demonstrate they support the mission of the BID, and may be contracted to perform services, asked to volunteer on committees, or approached to partner on initiatives.

Associate Membership is approved at the discretion of the NEBA board of directors. Applications are assessed on a case-by-case basis and membership expires for renewal one year after approval. The tiered Associate Membership fee is dependent on the type and nature of the business.

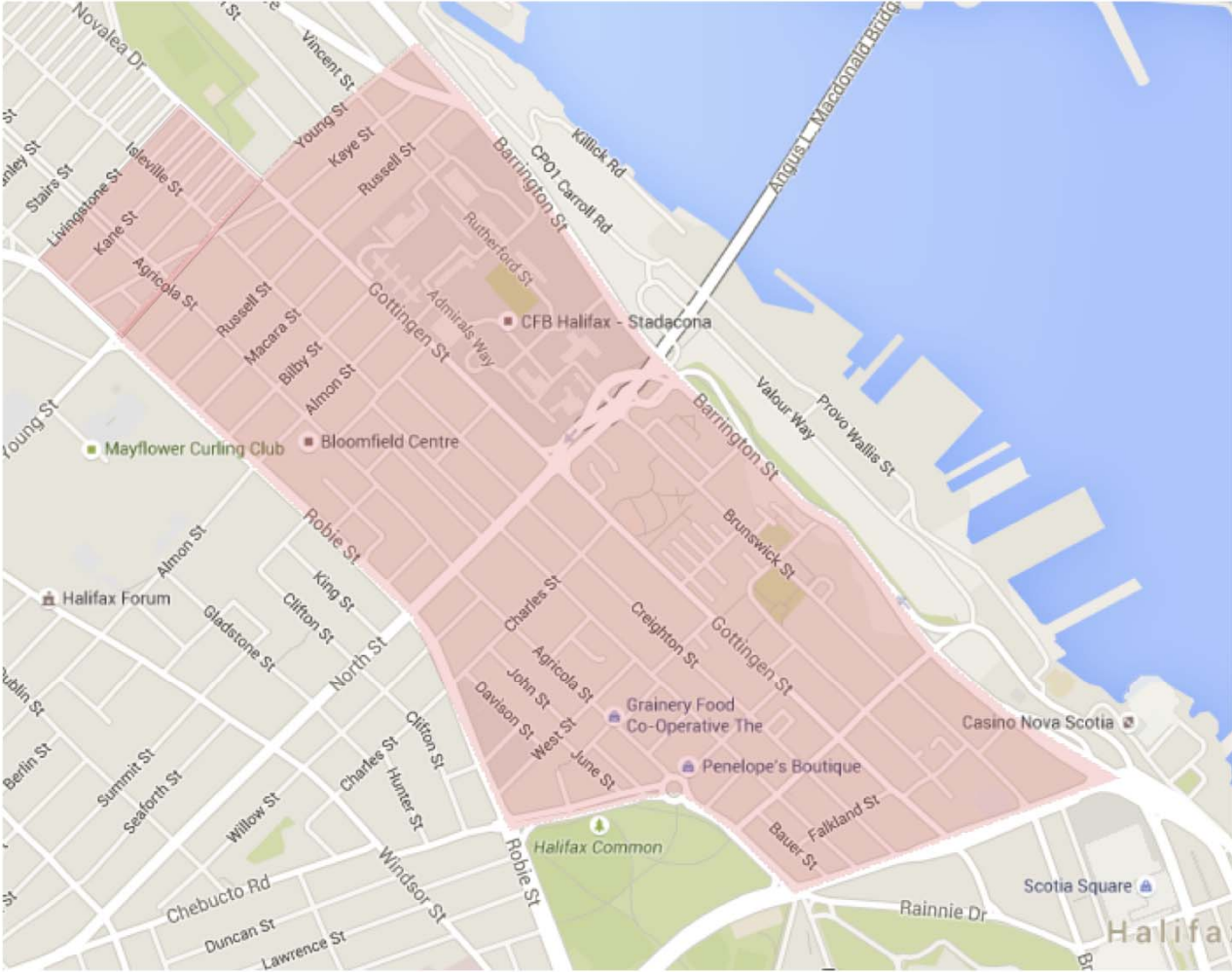

WELCOME TO THE NORTH END BUSINESS ASSOCIATION!

The North End Business Association is a one of eight Business Improvement Districts in Halifax. Established in 2011, NEBA is the most recently formed BID.

WHAT IS A BID?

A Business Improvement District (BID) is a special assessment district where business people join together to promote and improve the economic vitality of the area. The establishment of a BID provides a unique opportunity for business owners, and commercial property owners, to promote their mutual goals of creating safe, attractive, and interesting commercial place aimed at stimulating business.

HOW IS A BID FUNDED?

BIDs are supported by an area rate levied on the commercial land owners in the BID catchment area. This levy is enabled by Section 70 of the Halifax Regional Municipality Charter (2008) for services related to beautification, marketing, public parking, and economic development. In 2021/2022 the area rate for NEBA is \$0.16/\$100 of assessment, with a minimum levy of \$350 and a maximum levy of \$10,000. The area rate is approved every year at the Annual General Meeting and is collected through HRM and then transferred to the Association.

WHO ARE OUR MEMBERS?

NEBA has approximately 250 commercial properties and 450 businesses. All commercial property owners and business owners leasing or renting commercial space with the BID boundaries are automatically members of the association.

NEBA has a non-voting Associate Membership option to businesses located within the Associate Membership boundary. The intent of the Associate Membership is to enable home-based businesses and businesses immediately adjacent to the BID area to join NEBA and become active members of the local business community organization. Associate Memberships will be renewed on an annual basis.

The number of vacancies varies each year, but must be greater than one-third and less than one-half.
